**EXPIRY OF LISTED OPTIONS**

We are writing to you as a holder of LRVO listed options in Larvotto Resources Limited to remind you that the options will expire at 5.00pm (WST) on 1 December 2024.

Your option holding may be exercised in whole or in part by payment of \$0.30 for each option by no later than 5.00pm (WST) on 1 December 2024. If payment is not received by 5.00pm (WST) on 1 December 2024, the options will lapse and all rights under the options will cease at that time.
