This Community Consultation Report comprises Component 4 of the Annual Activity Report for EL 3326.

A.Executive Summary

The Hillgrove Mines Pty Ltd ("**HMPL**") parent company, Red River Resources Limited was placed under voluntary administration in November 2022 until its purchase by Larvotto Resources in December 2023.

HMPL has since recommenced exploration activities however this has been focused primarily on Freehold (HMPL-owned) and as such direct community consolation has been limited to the quarterly Hillgrove Progress Association meeting, attended by the General Manager Matt Varvari, a letter drop associated with LIDAR and a single land access agreement.

Larvotto has continued to release regular ASX announcements, to mark key milestones and tell the Hillgrove story as it evolves and restarts production, with the aim of engaging with the wider community.

HMPL (now part of Larvotto Resources), has sought to implement a residential employment model, and to assist with this strategy, opened the Hillgrove Hub in Armidale, on the 10th of April 2025. The Hub, a high-profile and easily accessed location, provides information and engagement with the wider community and providing a vital link to one of the largest urban areas associated with the Project.

Due to a lack of activity on EL3326 in the reporting period, no issues were raised by the community nor complaints received. No responses or actions have been necessary.

HMPL has also started consultation with Crown Lands regarding Section 265 agreements and will continue to do so. No agreements have been reached during this reporting period

HMPL has also been working towards private land access agreements, the first of which was executed in August 2024. This agreement covers land referred to as Hillview which contains the McGlassons Scheelite deposit and potential Clarks Gully strike extensions.

Another three access agreements have been signed for a total of four within this reporting period.

28th November 2024 covering Kindooroo property associated with the northwest strike extension of Syndicate Mine, part of the Metz mining centre.

18th March 2025 covering the access road into the Metz mining centre from Metz Lookout Rd and associated with both access roads and both the northwest extension of Syndicate Mine and the west-northwest extension of Blacklode both of which are part of the Metz mining centre.

18th June 2025 covering the property referred to as the Slaughter Yards which is neighbouring the Freehold mining centre.

Landholder liaison/negotiations

There are multiple landholders within EL3326 that will be contacted to negotiate LAA's to complete geological mapping and soil sampling and potentially drilling activities.

The formulation of a land access agreement regarding the property at Hillview, was executed on the 22nd of August 2024. The agreement covers 8-10 reverse circulation drillholes and the excavation of associated drill sumps. All drill collars and access are within the bounds of Mining Lease 0714. Should the need to extend the works into EL3326 the agreement will require amendment.

It is anticipated that in the next reporting period, land access agreements will be sought with multiple landowners (Figure 1):

- Greenvale property potential drill collars and access
- Oakleigh property conduct soil sampling and mapping
- Kiama East property conduct soil sampling and mapping
- Kiama property conduct soil sampling and mapping
- Crown Lands Access, soil sampling and mapping.
