

Drilling Success at Blacklode

Diamond Drilling Highlights

- Results received from Larvotto's first-pass diamond drilling from the Blacklode Prospect have returned wide, consistent zones of antimony and gold mineralisation
- High-grade, near surface mineralisation identified, targeting the western extension of the Blacklode structure where it intersects the Syndicate lode. Highlight down-hole intercepts include:
 - BLK101: 15 m @ 5.24g/t AuEq from 42 m
 - o Incl. 4.2 m @ 14.46g/t AuEq from 49 m
 - BLK102: 14.8 m @ 3.48g/t AuEq from 95 m
 - BLK103: 9.1 m @ 5.19g/t AuEq from 63.6 m
- This drilling will form part of the Resource and Reserve upgrade planned for Metz Mining Centre

Larvotto Resources Limited (**ASX: LRV**, '**Larvotto**' or '**the Company**') is pleased to advise it has received results from the Blacklode drilling program, located within the Company's 100%-owned Hillgrove Antimony-Gold Project in New South Wales.

Managing Director, Ron Heeks, commented:

"The ongoing drilling program across Hillgrove continues to demonstrate the Project's potential to grow our resource base. These latest results reinforce our optimism, with first-pass drilling at the Blacklode Prospect confirming high-grade gold and antimony intercepts, with the best result of 15m @ 5.24g/t AuEq from 42m, and additional mineralised splays and unmined halos, as seen at Eleanora.

Drilling is also targeting Freehold, with two rigs spinning and extensional and confirmatory drilling at Clarks Gully. This exploration strategy balances near-mine growth with broader district potential, positioning Hillgrove for both immediate resource additions and long-term upside. With four rigs planned to continue into 2026, we expect a consistent flow of results from the drilling programs across the Hillgrove site."

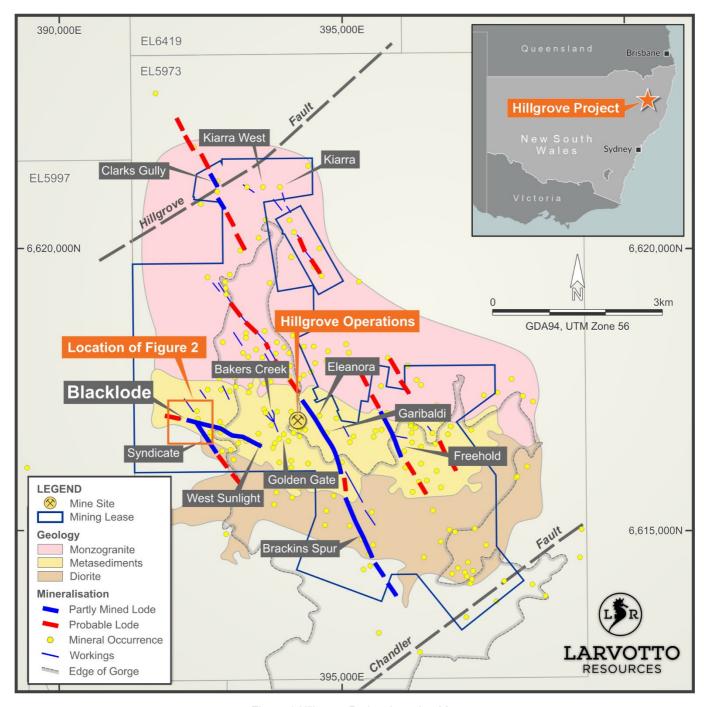


Figure 1 Hillgrove Project Location Map

The assay results are from the first diamond drilling conducted at the Blacklode Prospect by Larvotto since Project acquisition (Figure 1). Results received from the first four drill holes (BLK101 – 104) returned wide zones of Au-Sb mineralisation with a central high-grade core from the main Blacklode structure and mineralised zones from additional unknown parallel structures.

Drill intercepts including **15m @ 5.24 g/t AuEq** from 42m, (including **4.2 m @ 14.46g/t AuEq** from 49m) in BLK101, and **14.8 m @ 3.48g/t AuEq** from 95 m in BLK102, highlight the potential for significant upside in this shallow, underexplored zone of mineralisation proximal to existing infrastructure and accessible from underground workings.

Drilling is ongoing and additional drill holes have been planned to further test and define the extent of this highly prospective zone of mineralisation and other underexplored parts of the Metz system.

Blacklode Diamond Drilling

The current drilling at the Blacklode Prospect is designed to:

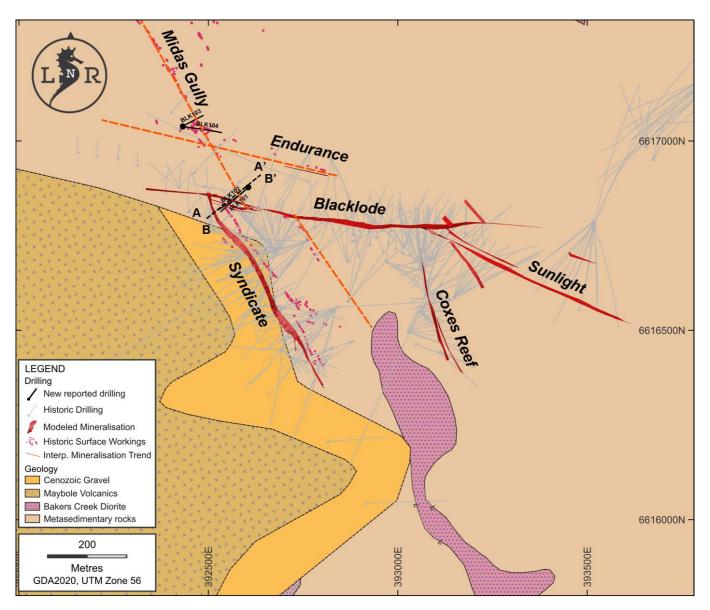


Figure 2 Blacklode diamond drill hole location plan with named mineral systems

- Target the confluence of the Blacklode and Endurance mineralised structures with the Syndicate and Midas Gully splays (Figure 2).
- To test the hangingwall and footwall zones for additional mineralised parallel structures and splays, as Larvotto has identified at the Eleanora deposit.

The Metz Mining Centre, a structurally controlled, vein-hosted gold-antimony rich mineralised system has been extensively explored and exploited. The Metz Mining Centre includes the Blacklode, Sunlight, and Syndicate systems, along with smaller splays, including Coxes Lode. The Western extent of the Blacklode system was targeted with this round of drilling. Blacklode is an approximately 1km long, predominantly





E-W, subvertical shear structure. Drilling is targeting this and the cross-linking ductile interaction where the mineralisation approaches the NW-SE-striking extensional shears of the Syndicate and Coxes Lode systems.

Drill holes BLK103 and BLK104 successfully targeted the highly prospective Midas Gully and Endurance structures. Additionally, a significant number of previously untested, mapped historic surface workings in and around the known mineralised area all warrant future drill testing.

Despite the long history of the historic Metz Mining Centre, extensive exploration potential still exists, as confirmed by the most recent round of drilling into Blacklode.

In Figure 2, recent drill holes are displayed as thick black traces, previous Larvotto and historic drill holes are displayed as thin grey traces. The modelled mineralisation sliced to 1600mRL is shown as a red line in order to show the intercept points of drill holes. The interpreted mineralisation trends, which will be the focus of future drilling programs are noted as dashed orange lines. Note, hole names are labelled along the projection of the drill trace of holes for better clarity. The relative position of the cross-sections are shown as dashed traces in plan view (A-A' and B-B').





The drilling indicates Hillgrove's strong potential to produce excellent gold and antimony grades outside and along strike from historic mining, as well as adjacent to areas historically mined for very high-grade ore.

The better significant drill intercepts are summarised in Table 1.

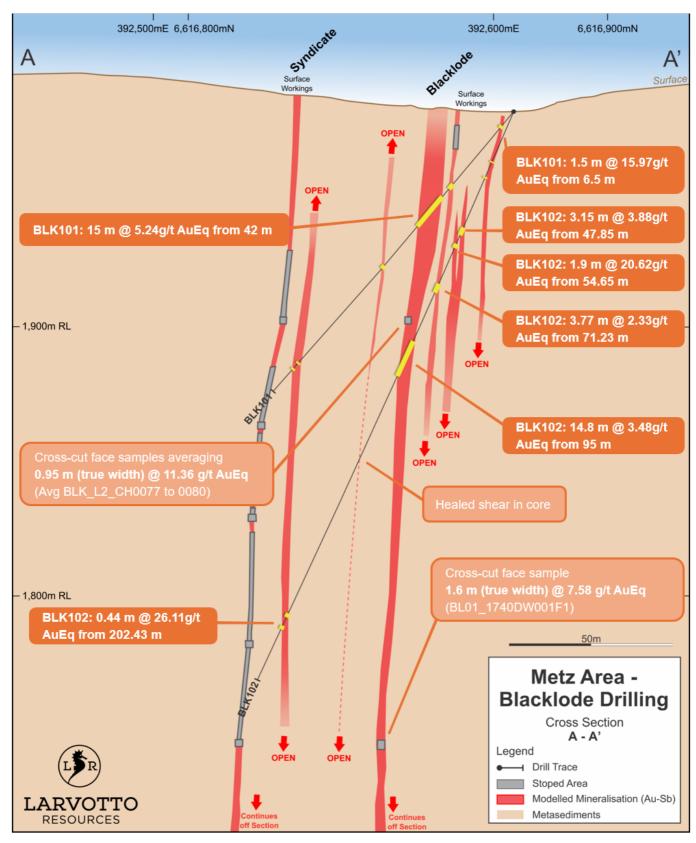


Figure 3 Blacklode Cross-section A-A' (top 300m)



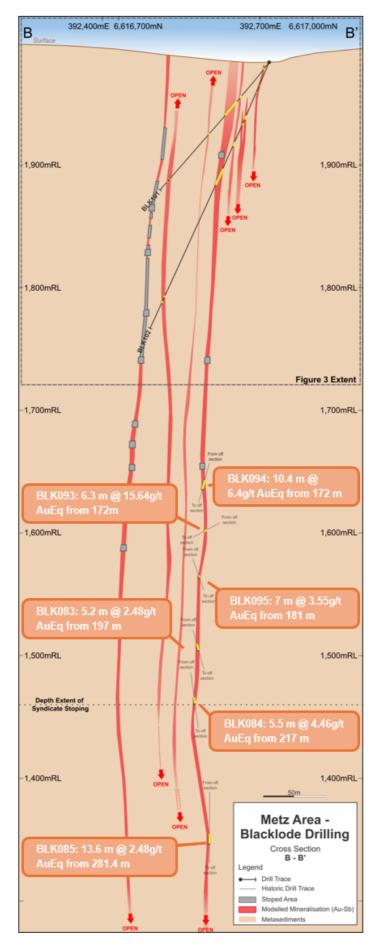


Figure 4 Blacklode Cross-section B-B'

A drill hole cross-section for recent drill results is shown in Figure 3. Diamond drill holes BLK101 and BLK102 have identified thick, high-grade intervals of mineralisation in previously unexplored areas. Of interest is the numerous stacked, sub-parallel veins of mineralisation intersected by the drilling, all in close proximity to existing underground infrastructure. These intercepts have the opportunity to provide near-term mineable high-grade material which can directly add to the life of mine. Figure 4 shows the current known extents of the overall Syndicate-Blacklode system in this area of recent drilling. BLK101 and BLK102 show that the Syndicate-Blacklode mineral system has approximately 700 metres of vertical continuity and remains open at depth.

Future Plans

Larvotto's focus on resource growth at Hillgrove continues, with four diamond drill rigs drilling across the Metz and Freehold areas as part of a coordinated near-mine and regional exploration strategy.

At Metz, drilling is currently focused on defining the convergence of the Blacklode and Syndicate structures and testing extensions beneath historical workings. Follow-up step-outs are planned along the west-north-west and north-west strike extensions of both the Blacklode and Syndicate mineralised systems, where recent drilling has confirmed multiple stacked, high-grade zones proximal to existing underground infrastructure. These programs aim to expand the current resource base and identify new mineralised splays that could deliver additional mineable material to the Metz Mining Centre.

At Freehold, located 1.2km east of the Hillgrove processing plant, drilling continues to target near-surface mineralisation and extensions at depth and along strike, while extensional and confirmation drilling is advancing at Clarks Gully to build upon previously defined resources. Integration of assay results from the recently completed Eleanora—Garibaldi program into an updated Mineral Resource model will guide the next round of targeted drilling across Hillgrove.

Sub samples of diamond drill core were collected through cutting in half by a diamond saw. Sub-samples of and reverse circulation chips were collected through on-rig cyclone splitter, splitter or spear methods. In general, most samples within the mineralised zones were sampled between 0.15 and 2m intervals. For diamond core this was based on geology, alteration, and mineralisation contacts. For reverse circulation sampling the sample intervals were generally 1m. Where mining has occurred underground channel sampling was undertaken by experienced geologists. Channel samples were sampled to geological/mineralisation contacts via rock chipping across development drive faces. The channels targeted the central high-grade antimony mineralisation and often do not sample the Au-As edge mineralisation. The channels were sampled perpendicular to the strike of the lode and spaced at 1.5m- 4m along strike. Individual samples were generally between 0.1 and 1m in length and 0.5 to 5kg in size. Pre 2007 samples were crushed to minus 1cm and riffle split with 100g pulverised and a 10g portion collected for digestion and AAS analysis. Drill and channel sample preparation and analysis from January 2007 to mid-2024 were as follows:
